### **FORAGER AUSTRALIAN SHARES FUND (FORAGER) (ASX: FOR) INDICATIVE DISTRIBUTION AND SUSPENSION OF DISTRIBUTION REINVESTMENT PLAN (DRP) – CLARIFICATION OF APPENDIX 3A.1**

On 4 June 2019, an Appendix 3A.1 was lodged with the ASX advising of an indicative distribution to Forager unitholders of \$0.01 per unit and changes to the DRP for the year ended 30 June 2019.

FOR is currently trading at a discount to Net Asset Value so it is not in the best interests of investors to re-invest the distribution at NAV, as per the current DRP plan. Therefore the Directors, in consultation with the Responsible Entity of the fund, have decided to suspend the operation of the DRP for the year ended 30 June 2019.

With the suspension of the DRP, all FOR unitholders will receive their FOR distribution in cash. If investors choose, they can reinvest. Consequently, unitholders are encouraged to promptly ensure their payment details are up to date with FOR's registry. Your distribution preferences will not be changed if the DRP is re-enacted.
